

Kentucky Building Inspector Certification Program (KBICP) NCPCCI Exams vs. ICC Exams

The Office of Housing, Buildings and Construction/ Division of Building Code Enforcement has accepted the ICC's building inspector certification examinations as an equivalent alternative to the NCPCCI examinations since November of 2004. The administrative regulation that governs the KBICP was amended in 2005 to allow the Office to accept or recognize other examinations as equivalent to the listed NCPCCI examinations. The ICC Certification Program has demonstrated that the ICC building inspector certification examinations cover the same codes and require the same level of knowledge as the NCPCCI examinations. The ICC exams are organized differently and include combination exams that allow the applicant to complete the same level of certification with less time, money and effort. Please note that the ICC exams have more questions than the typical NCPCCI exams that have fifty (50) multiple choice questions.

LEVEL III CERTIFIED BUILDING INSPECTOR

Here are the ICC exams that are equivalent to the NCPCCI exams required to be a Kentucky Level III Certified Building Inspector (includes Plans and Specifications Inspector).

LEVEL II CERTIFIED BUILDING INSPECTOR

Here are the ICC exams that are equivalent to the NCPCCI exams required to be a Kentucky Level II Certified Building Inspector.

* **NOTE:** Level II's that aspire to be Level III should take M3 instead of M2 and will save themselves cost of one examination.

LEVEL I CERTIFIED BUILDING INSPECTOR
